Saint Bernadette Parish will hold its **Rummage Sale** on **Saturday, June 29**, from 9:00AM to 5:30PM. Saint Bernadette is located at 8200 West Denver Avenue, in Milwaukee (approximately 3 blocks South of Good Hope Road, access Denver from either 76th or 91st Streets).

Set-up time is from **6:30PM until 8:00PM on Friday evening or 8:00AM until 9:00AM on Saturday morning**. Please make sure you are ready with your booth by 9:00AM. **NO SMOKING** is allowed in the building or in the grotto.

The cost to rent one 6-foot table with 2 chairs or a 6-foot space (if no table is desired) is \$20.00. **Rent 2 or more tables or spaces for a fee of \$17.00 for each table or space.**

PLEASE NOTE: A 6-foot table is the actual size you are renting. If additional space is needed, you would be required to rent the table or space on either side of you. Overflowing into the aisles is not permitted as **THE AISLES MUST BE KEPT CLEAR**. In addition, **after unloading your vehicle, please move your vehicle farther from the building entrance to allow convenient parking for customers.**

Below is an application for table or space rental. Return the application with your remittance as soon as possible, **but no later than Monday, June 17**. Your canceled check is your receipt.
